

Notice for Extension of Timeline for Submission of Resolution Plan
(Under Regulation 36B(6) of the IBBI (CIRP) Regulations, 2016)

This is to inform all stakeholders and Prospective Resolution Applicants (PRAs) that Bymedo Healthcare LLP (“Corporate Debtor”) is presently undergoing Corporate Insolvency Resolution Process (CIRP) pursuant to the order of the Hon’ble National Company Law Tribunal (NCLT), Kolkata Bench, dated 28th April 2025.

During the 6th Meeting of the Committee of Creditors (CoC) held on 12th January 2026, the CoC, after due deliberation and upon requests received from multiple PRAs, approved an extension of the timeline for submission of Resolution Plans of 15 days expired on 03rd February’26, further extension of 7 days granted, and the revised date ended on 10.02.2026. Further, since no Resolution Plan being submitted as on 10th February’26, one PRA requested 10 days time to submit the Resolution Plan, Therefore, the revised date of submission of Resolution Plan will be 20th February’2026 since the committee approved the same in exercise of its powers under the Insolvency and Bankruptcy Code, 2016 and Regulation 36B(6) of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016.

- Resolution Plans shall be submitted strictly in accordance with the mode and manner prescribed in the RFRP, including submission in both physical and electronic formats, within the revised timeline.
